- (vii) Settlement of advance(s) / dues of any section of the University including affiliation fees if pending with the College and any other deficiency observed by any regulating authority, please submit within 01 (One) month, otherwise, no action will be taken on teacher's proposal for approval / PG Recognition received from your College.

Important Note:

- 1) This Continuation / Extension of affiliation is issued for the A.Y. 2025-2026 subject to the permission of State Government (as applicable). Further, if the permission is declined by the said authorities, this Continuation / Extension of Affiliation shall be treated as cancelled. The College is not authorized to admit students for 1st Year of the course until receipt of permission of State Government (as applicable).
- 2) The admission shall be done through the Competent Authorities only.
