As per the provision of section 65 (4) of Maharashtra University of Health Sciences Act 1998, I am directed to inform you that, on the basis of the Local Inquiry Committee report the Hon'ble Vice Chancellor is pleased to Grant First Time Affiliation to your College, "Vedantaa Institute of Nursing Sciences, Village Sasvand, Dhundalwadi, Tal. Dahanu, Dist. Palghar - 401 606" for B.Sc Nursing Course for the academic year 2021-22 subject to approval of Academic Council as per the provision under section (65)2 of MUHS Act 1998, by following due procedure. However, this affiliation is subject to the following conditions: -

- 1) The intake capacity shall be 40 students for B.Sc Nursing Course.
- 2) Fulfilment of following deficiencies within 3 months from the date of issuance of this letter to the University (Academic Section).
 - i) Appointment of Eligible Vice-Principal.
 - ii) Needs to purchase nursing books & equipments.
 - iii) Lab physical set up needs to be modified.
- 3) Rules and Regulations made by Indian Nursing Council, New Delhi, Govt. of Maharashtra and the University, as amended from time to time, will be binding on the College.
- 4) The college should obtain approval of teachers from the Maharashtra University of Health Sciences, Nashik.

- 5) The College should obtain the permission for admitting the students from the Admission Regulating Authority, Mumbai.
- 6) The college should obtain approval of fee schedule for the admission of the students from the Fee Regulating Authority, Mumbai.
- 7) This First Time Affiliation is Valid for Academic year 2021-22 only.
- 8) The next batch of students shall not be admitted unless continuation of affiliation from the University is obtained by the college.
- 9) Bank Guarantee should be submitted within a period of 1 month from the date of issuance of this letter to the University.

Note:- The cutoff date of admission for A.Y. 2021-22 is over, therefore no student shall be admitted in the College for Academic year 2021-22.
