It is to inform that the Medical Assessment Rating Board (MARB) of National Medical Commission (NMC) considered the Assessor's report (19.04.2022) together with the recommendations of the PG Expert Group on the physical and other teaching facilities available at Vedantaa Institute of Medical Sciences under Maharashtra University of Health Sciences, Nashik in the State of Maharashtra Starting of MD (Anaesthesiology) course u/s 26(1)(a)(b), 28(1)(2) and 61(2)of the NMC Act, 2019 for the academic year 2022-2023 and decided as under:

"The Medical Assessment and Rating Board (MARB) considered the Assessor's Report (19.04.2022) and after virtual Hearing (08.09.2022) decided to issue Letter of Intent for Starting of MD (Anaesthesiology) course at Vedantaa Institute of Medical Sciences under Maharashtra University of Health Sciences, Nashik in the State of Maharashtra u/s 26(1)(a)(b), 28(1)(2) and 61(2) of the NMC Act, 2019 prospectively i.e. from the academic session 2022-23 for <u>07 (Seven)</u> (Seats) per year till the first batch admitted against the approved number, appears in the final examination of the said course. It is also to inform that the Medical Assessment and Rating Board (MARB) approved MD MD (Anaesthesiology) course for <u>07 (Seven)</u> (Seats) as per available facilities with prospective effect i.e. for the academic session 2022-23 Vedantaa Institute of Medical Sciences under Maharashtra University of Health Sciences, Nashik in the State of Maharashtra u/s 26(1)(a)(b), 28(1)(2) and 61(2) of the NMC Act, 2019 may be issued.

In view of the above decision, the Commission had decided to obtain undertaking/ essential document for issue of Letter of Permission for starting/increase in seats for the academic year 2022-23:-

- The applicant should provide all infrastructural facilities in terms of teaching and non-teaching staff, buildings, equipment and hospital facilities as per National Medical Commission norms. It is further requested to you, to give an undertaking that any other courses (Fellowships/DNB) being run in the concerned specialty, may be discontinued.
- 2. No student should be admitted in the above courses till the formal permission of the Medical Assessment and Rating Board (MARB).
- 3. The Private Medical College should Provide Bank Guarantee of required amount in favour of National Medical Commission, New Delhi valid for three years or till the course is recognised, whichever is later, from a nationalized/ scheduled Bank as per NMC/MCl's norms. However, medical colleges/institutions governed by the State Govt. are required to furnish only an undertaking to provide funds in their budget till the facilities are fully provided as per time bound programme indicated by them.
