- c) Those UG / PG qualifications that are not yet recognized by the Central Govt, it is mandatory for the college to apply to the Central Council through Central Govt, and ensure that Permitted / Not Recognized qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year & no student shall be admitted in such courses.
- d) Compliance to show cause dated 25/08/2020 issued by Board of Governors in Super-Session of Medical Council of India, Delhi with satisfactory Compliance letter from MCI/NMC towards the said discrepancies. (Copy attached)

You are requested to comply with the above mentioned deficiencies within 03 months' time period without fail and submit compliance report.

1) This continuation / Extension of affiliation is issued for the A.Y. 2020-2021 subject to the permission of Medical Council of India and / or Govt. of India and if the permission is declined by the said authorities this Continuation / Extension of Affiliation shall be treated as cancelled. The college is not authorized to admit the students for 1st year of the course until receipt of permission of the Medical Council of India and / or Govt. of India.
