

ADMISSION OF NON MAHARASHTRA DOMICILE STUDENTS

1. The Government of Maharashtra, in the High Court of Bombay, by Affidavit - in- Reply dated 30.09.2020, in the matter of Vedantaa Institute of Academic Excellence Pvt. Ltd & Anr. Vs State of Maharashtra & Ors., W.P. No. 92812 of 2020 have agreed to allow all the candidates applying for 15 % Institutional quota irrespective of candidate is domicile of Maharashtra or otherwise. **Online applications of Non Maharashtra domicile in 15 % Institutional quota will be accepted on All India basis** including Non Resident Indians and Overseas Citizen of India, who have appeared for National Eligibility Cum Entrance Test and declared eligible. Such candidates will be able to register online in 15 % Institutional quota seats.
2. In light of the said Affidavit filed by the Government of Maharashtra and as per the provisions of Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admission to the Full Time Professional Undergraduate Medical and Dental Courses) (Amendment) Rules, 2017, **the**

Non Maharashtra Domicile candidates (NEET Eligible) can also now apply under 15 % Institutional quota for admission in M.B.B.S. Course in our institute.

And therefore all the desirous **Non Maharashtra Domicile NEET -2020 Eligible candidates** can take note of this and can participate in admission procedure for the academic year 2020-21, going to be conducted by the Commissioner, State CET Cell, Maharashtra for admission in M.B.B.S. course under 15 % Institutional quota including NRI quota in our institute as per the procedure prescribed by the Competent Authority in this behalf.
