**GENERAL INSTRUCTIONS FOR STUDENTS AND PARENTS
FOR INSTITUTIONAL LEVEL ROUND**

(NEET-UG -2020)

1. The State CET Cell will declare vacancy position of M.B.B.S. seats of our institute on 8/1/2021 and same will be filled through Institution Level Round, as per the directions/guidelines issued and schedule prescribed by the State CET Cell, from time to time.
2. It is explicitly clarify that, the institute has not authorized/appointed any person/individual/agent/agency including any Non- Teaching or Teaching staff of our institute to get admission in our institute to prospective students. If any prospective candidate is approached by any such person/s or agency for assuring admission in our institute, this may immediately be brought to the notice of the Dean of the institute. (Email - info@vedantaa.institute, Phone No.: 8599903838, 8599903939, 8599904040 or in-person). Further the institute do not accept any amount in cash or kind, directly or indirectly in excess of the fee approved by the Regulation Authority. The General Public are therefore cautioned not to be lured by any such person/s offering admission in our institute. The institute shall not be responsible if any

candidate or parents indulge/dealing in such unauthorized way of admission in our institute.

3. The eligible desirous candidate can apply for the same, only in-person, at the institute. The candidate has to come personally to the institute for the participation in the admission process. Application through e-mail, on-line or any other means except 'in-person' shall not be accepted and same shall be rejected out-right.
4. The details of tuition fees, hostel fees and refundable deposit for the students admitting in the academic year 2020-21, is available on our website, however the short details of fees is as follow.

1	Tuition Fees for 85 % - State Quota	Rs. 16,60,000/-
2	Tuition Fees for 15 % - NRI/Institutional Quota	Rs. 38,00,000/-
3	Hostel Fees	Rs. 1,00,000/-
4	Refundable Deposit	Rs. 25,000/-

5. All the fees are required to be paid strictly in the form of Demand Draft only. The D.D. shall be in favour of "**Vedantaa Institutes of Academic Excellence Pvt. Ltd**", payable at Daman.
6. Keeping in view of Pandemic of Covid -19, only student along with one parent/guardian will be allowed to enter in college premises. The necessary sitting and parking arrangements are made for the additional person accompanying with student for the purpose of admission.



7. The candidate have to submit completely filled application form along-with the self attested photocopy of necessary documents, as prescribed by the State CET Cell, at the designated counter in college.
8. The application form will be scrutinized by the Designated Authority/ person, as per the direction of State CET Cell/Competent Authority, in this behalf, and a merit list of students will be prepared and will be published on institute website and at the notice board in college.
9. The selected candidate has to report before the Dean/Designated Authority, as per the direction of State CET Cell/Competent Authority in this behalf, along-with all original documents, as prescribed by the State CET Cell, along with the tuition fees and other fees (Hostel fees, and Refundable Caution Money) as prescribed above, in form of "Demand Draft", in-person only.
10. If the candidate fails to remain present, in-person before the Dean/Designated Authority in this behalf, for the counselling for admission with all Original Prescribed documents and prescribed tuition fees in form of Demand Draft, the candidature ship of such candidate shall not be considered and his/her claim for admission shall be rejected.
11. The entire process of admission conducted through Institute Level Round will be conducted under the supervision of observer appointed by the Competent Authority for this purpose and as per the directions issued by the Competent Authority in this behalf, from time to time.
12. As per the rule 16.2, of Information Brochure Published by State CET Cell, "If any candidate/authorised representative or person accompanying is found

obstructing the counselling and/or admission process, or trying to influence in unlawful manner/creating nuisance, the candidate shall be liable for disqualification from the process of selection and appropriate legal action will be taken. The decision taken by the Competent Authority in this respect shall be final and binding.

It is once again informed to all desirous candidate/parent that the Government of Maharashtra by G.R. dated 20/JULY/2017 have decided not to provide re-imburement /scholarship in tuition fees for the students who desire to get admission in this institute and therefore the student/parent shall not be entitled for the claim of scholarship /re-imburement of tuition fees provided by the Government of Maharashtra in any scheme of State/Central Government and therefore the students /parent have to pay entire amount of tuition fees from their side to the institute.
