STRAY VACANCY ROUND FOR UNDER GRADUATE MEDICAL COURSES (MBBS)

NEET UG 2023

1. The State CET Cell have/will declare vacancy position for Under graduate Medical Courses (MBBS) of our institute on 26/09/2023 and the same will be filled through Institutional Level Stray Vacancy Round, as per the directions/ guidelines issued and schedule prescribed by the State CET Cell, from time to time, in this behalf.
2. It is explicitly clarified that, the institute has not authorized/appointed any person/individual/agent/agency including non- teaching or teaching staff of this institute to get admission in this institute to prospective students. If any prospective candidate is approached by any such person/s or agency for assuring admission in this institute, this shall immediately be brought to the notice of the Dean of the institute. Phone No. 8599903838, 8599903939, 8599904040 or in-person), Further the institute do not accept any amount in cash or kind, directly or indirectly in excess of the fee approved by the Regulation Authority. The General Public are therefore cautioned not be lured by any such person/s offering admission in this institute. The institute shall not be responsible if any candidate or parents indulge/dealing in such unauthorized way of admission in this institute.
3. The eligible desirous candidate must apply through Online mode (through email on nodalofficervimsdahanu@gmail.com only) in the prescribed

format available on institute website (www.vedantaa.com) separately for State Quota and Institutional Quota.

4. The details of tuition fees, hostel fees and refundable deposit for the students admitting in the academic year 2023-24, is available on institute website, however the short details of fees is as follow.

5. All the fees are required to pay strictly in the form of Demand Draft only. The D.D. shall be in favour of “**Vedantaa Institutes of Academic Excellence Pvt. Ltd**” Payable at Somnath Dabhel.
6. The candidate has to submit completely filed application form along-with the self-attested photocopy of necessary documents, as prescribed by the State CET Cell, through Email only on nodalofficervimsdahanu@gmail.com.
7. The application form will be scrutinized by the Designated Authority / person, as per the direction of state CET Cell/ Competent Authority, in this behalf, and a merit list of students will be prepared and will be published on institute website and at the notice board of college.
8. The selected candidate has to report before the Dean/Designated Authority for the joining process, as per the direction of State CET Cell / Competent Authority, in this behalf, along-with all original documents, as prescribed by the State CET Cell, along with the tuition fees and other fees (Hostel fees, and Refundable Caution Money) as prescribed above, in form of “Demand Draft”, in-person only.

9. If the candidate fails to remain present, in-person before the Dean/Designated Authority in this behalf, for the joining process along with all the original prescribed documents and prescribed tuition fees in form of Demand Draft, the candidature of such candidate shall not be considered and his/her claim for admission shall be rejected.
10. The entire process of admission of Institute Level Stray Vacancy Round will be conducted Online, as per the directions issued by the Competent Authority in this behalf, from time to time.
11. As per the rule, of Information Brochure Published by State CET Cell, “If any candidate/authorized representative or person accompanying is found obstructing the counselling and/or admission process, or trying to influence in unlawful manner/creating nuisance, the candidate shall be liable for disqualification from the process the process of selection and appropriate legal action will be taken. The decision taken by Competent Authority in this respect shall be final and binding.

It is once again informed to all desirous candidate/parent that the Government of Maharashtra by G.R. dated 20/07/2017 have decided not to provide re-imbusement / scholarship in tuition fees for the students who desire to get admission in this institute and therefore the student / parent shall not be entitled for the claim of scholarship / re-imbusement of tuition fees provided by the Government of Maharashtra in any scheme of State / Central Government and therefore the students / parent have to pay entire amount of tuition fees from their side to the institute.
